

Objective

The University of Bristol is one of the worlds most renowned universities. Recognised for its global cutting-edge research and innovation, it has over 3,000 academic staff and 27,000+ students.

The immediate issue for the University of Bristol was to increase department efficiency whilst improving cross-department collaboration on their contract portfolio. The primary challenge that they faced was that they previously completed their contract creation and reviews manually.

With a diverse portfolio of contracts which are frequently repeated due to the nature of work meant that their contractual processes were slow, lacked transparency, and fragmented. The University of Bristol set out to find a digital contracting solution that would automate their processes, improve multi department collaboration, whilst allowing for full control over process.
