## Challenges



### Siloed Data Quality

Data quality checks were isolated and inconsistent, making it hard to maintain standards across teams.



### Slow Rule Execution

Rule creation and execution required heavy developer involvement, delaying onboarding and innovation.



### Scaling & Cost Limitations

Legacy tools struggled with 500B+ rows and petabyte-scale data, leading to high compute/storage costs.



### Reactive Issue Resolution

Customers often found data issues before internal teams, risking churn and compliance failures.

Reusable, extensible rules library for rapid onboarding and policy enforcement. Auto-actions and self-healing capabilities to resolve issues before they impact customers.



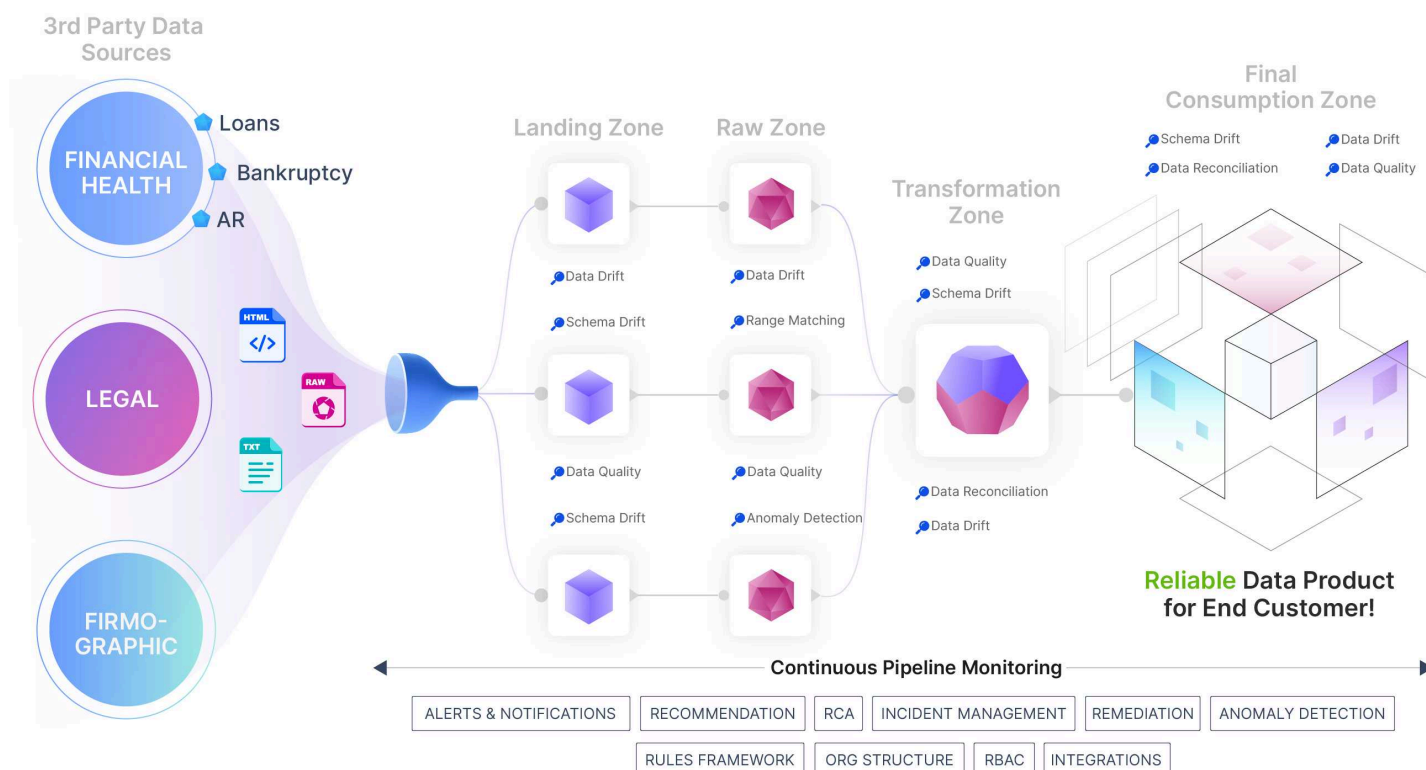
## Scalable, AI-Driven Operations

## How the Customer is Using Acceldata

- Ability to write data quality and validation rules using SQL, Python, and Spark
- Detecting schema, and attribute-based changes
- Pipeline observability enables quality checks on data in pipelines, including at landing zone, and in data assets
