# The Challenge

Despite known policy risk, the team had no benchmarking or perdevice metrics to validate what was working, or how they compared to industry standards. Manual reporting made it difficult to identify issues like redundant rules, unused access, or misconfigurations, leaving more than 6.400 medium control failures undetected and unaddressed.

#### **The Solution**
