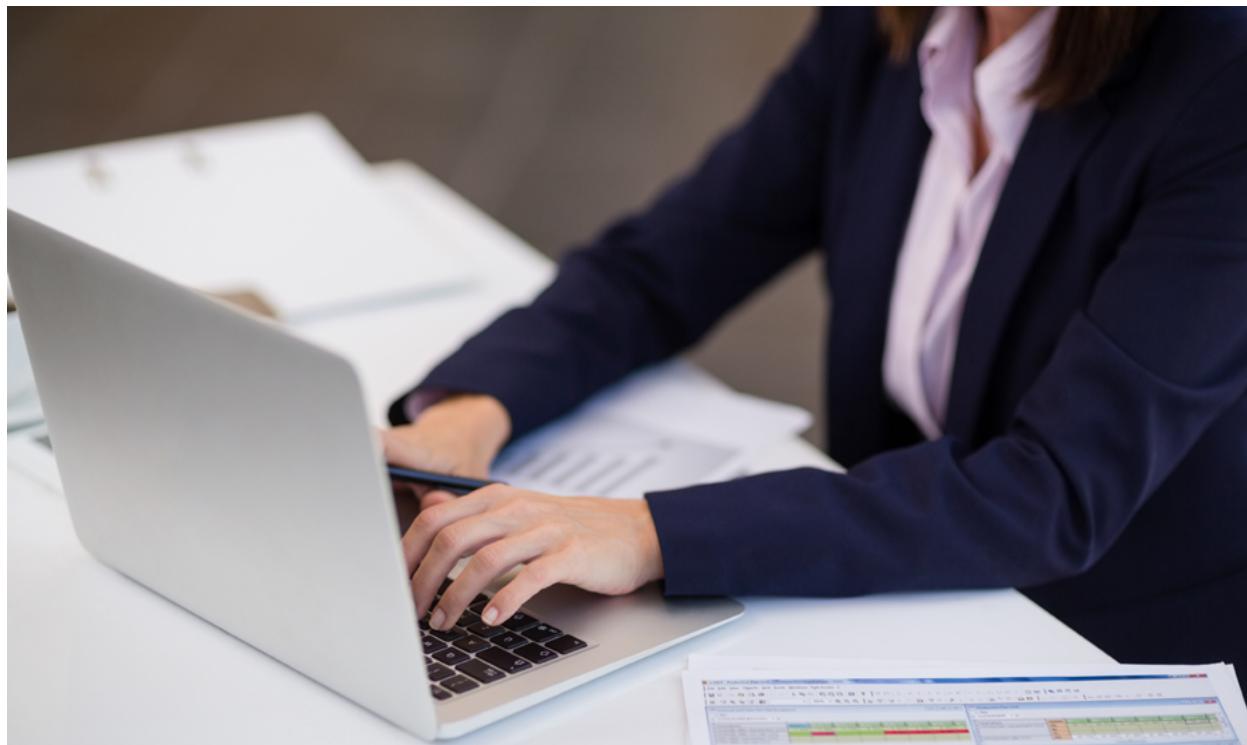

## Introduction

The management and information system used by Arce has been approved as the Quality Management System applicable to “Management, processing and tracking of Government licenses and authorizations” in accordance with the Quality Management System requirements: UNE EN ISO 9001:2000.

Given its rapid expansion over recent years, ARCEEP decided **to undertake a digital transformation project** with the implementation of a process management application that would allow the complete and continuous management of information, as well as reports, document management and remote access for all employees. In keeping with a philosophy of comprehensive service and its pursuit of maximum profitability and efficiency in the solutions and services it implements, and after a profound analysis of the customer's needs and goals, ARCEEP **opted for the AuraQuantic no-code applications platform, that provided everything needed to meet their requirements.**



## Challenge

ARCEEP is a company whose dedication makes it necessary for its consultants to move around for work. This means that **the consultants must have remote access to the data**. For this same reason, **they must also be able to telecommute so that the information can be updated as quickly as possible**.

On the other hand, document management is very important within the organization as it is the base of all development. For ARCEEP it was necessary to **create a document management accessible to both employees and customers, which also allowed them to incorporate new documents to the processes remotely** to update the status of the different legalizations. The document input is what triggers the start and end of production tasks and processes.

Another very important point for ARCEEP **was the need for reports on the actual situation of each case, which had to be obtained quickly and accurately**. These reports were needed to inform customers and also to ease the work of the employees when controlling deadlines and action plans.

An agile system was needed to handle the heavy workload and to distribute it between employees, because a process could not be left unattended to due to the absence of an employee.



## Solution

ARCE, whose work methodology pursues quick results and easy integration, chose a **solution based on AuraQuantic that seamlessly integrates with an external database** to manage all the necessary data for monitoring and control. This empowers ARCE to use the data from different applications.

From the **Document Management**, ARCE was able to set up the processes to start or end just by **introducing a document using System Tasks** (tasks performed by AuraQuantic automatically without human intervention) and Deviators that automated changes in the status of the information.

This was vital to give the application the dynamism the company needed. The situation of the processes can be changed at anytime, they can be closed or new ones can be launched by AuraQuantic system tasks.

The reports were developed using Reporting Services. The reports provide information on AuraQuantic internal processes. **External Portals were implemented for ARCEEP customers, giving them access to reports containing the current status of their projects and documentation.**

## Results
