THE CHALLENGE

To accommodate the needs of new customers in North America Cardinal Health needed to upgrade their labeling systems to meet the stringent FDA regulations. Cardinal also wanted to extend their branding to secondary labels in order to promote their products more effectively in the marketplace.

KEY OBJECTIVES:

- Meet FDA 21 CFR Part 11 requirements
- Supplied with full life cycle documentation
- Supplied with supporting GMP compliance
- Extend Cardinal branding to secondary labeling
- Validation of the complete solution once in situ
- Reduce user inputs and ensure data integrity
- A WYSIWYG (what you see is what you get) print preview was required as an aid in the label design stage and as a last check before printing.
- Initiate label printing from Oracle and utilise existing system
- Printing of the first label must start in less than 3 seconds.
- Flexible, highly featured label design capability
- Install of the new system needed to be complete at the first site within 3 months
- Overall improve labeling efficiency
- The new labeling systems were to be installed at two UK manufacturing sites, Brentwood and Romford in Essex.

THE SOLUTION

PRISYM ID's dedicated life sciences team responded to Cardinal Health's User Requirement Specification (URS) with a detailed proposal to install a solution based on PRISYM labelling solution, the world's only purpose designed labeling software for FDA 21 CFR Part 11 compliant applications. The proposal included validation of the complete solution once in situ.
