THE CHALLENGE: COMPLEX DISCOVERY UNDER TIGHT DEADLINES

Project Needs:

- Collect documents from 23 custodians
- Ingest 600 GB of data yielding over 3 million documents
- Generate ESI compliant productions

The firm needed to collect millions of documents, quickly identify communications and hiring policies, and produce on a truncated timeline. But their past experience had shown that coordination between separate service and software providers created significant inefficiencies and unnecessary risks. They needed a streamlined approach.

Forensic collection: speed without compromising defensibility

DISCO's certified forensics examiners conducted an expedited, remote collection of email accounts for all 23 custodians, eliminating the expense of on-site collection and fast-tracking data to the platform.

Project management: expertise-driven efficiency

DISCO's project management team consulted with the law firm's eDiscovery director in real time on ESI specifications, executed custom reproductions, and refined search terms. Through 20 iterations of search terms and rigorous early data assessment, they reduced the document population by 98%, from 3 million to 56,000 highly relevant documents that required review.

Managed review: Al-driven precision

DISCO Review completed the analysis of 56,000 documents within 13 days at a guaranteed cost of less than \$1 per document. Even when coding for multiple issues — responsiveness, privilege, PII, and confidentiality — the team averaged 50 documents per hour. And they maintained exceptional accuracy: only 1.9% of the reviewed population required quality control review.

Urgent custom production: 10-hour turnaround vs. 48-hour industry standard

When the firm urgently requested a same-day reproduction of previously delivered documents, DISCO beat industry expectations. Since DISCO images documents during ingestion rather than as a pre-production step, the project managers delivered this complex reproduction in 10 hours.
