Introduction

TOYOTA Spain promotes the ISO 14001 Environmental Management Standard throughout their dealer network in Spain relying on the GEATOYOTA application, which was developed on the AuraQuantic BPM Suite.

The use of the AuraQuantic BPMS has made environmental management in many centers both feasible and efficient. The platform simplifies performance improvement analysis and increases visibility with key performance indicators, dashboards, and charts. Furthermore, it ensures strict compliance with environmental regulations, minimizing the use of human resources.





Challenge

As part of its environmental commitment, TOYOTA Spain has implemented the ISO 14001 Environmental Management System throughout the Official Dealer Network. This system has been adopted by 65 dealers, which is more than 80% of the total number of TOYOTA dealers in Spain. The objective is for 100% to be certified in the near future.

Solution

An efficient management system was implemented to guarantee compliance with the ISO 14001 environmental regulation, reduce the risks of environmental harm, and optimize the processes which may impact natural resources. To implement this system, TOYOTA Spain decided to contract consultancy support for environmental management systems and entrusted the project to AUREN; a multidisciplinary consultancy firm specializing in Systems Standardization and Information Technology. AUREN conducted the consultancy to adapt the environmental processes for the TOYOTA Spain dealer network and provided support prior to certification.

Furthermore, AUREN proposed using the AuraQuantic BPMS platform to model and automate the processes related to the ISO 14001 regulation and other internal processes, which resulted in the creation of the GEA-TOYOTA solution. This was all complemented by the environmental Maintenance Compliance and Legal Requirements services provided by AUREN's technical specialists, including all Spanish municipalities with a TOYOTA center. The TOYOTA Spain Environmental Administrator also received training on the application. The platform has been instrumental in process automation and system management throughout the network. The entire system is now controlled by minimal staff at the TOYOTA Spain headquarters.



Solution

The corporate personnel at TOYOTA Spain, along with their internal consultants, auditors, environmental officers, and the managers of the different groups involved, have access to the system, which enables all members of the extended team to participate in the system processes in a coordinated and homogenized manner. Participants are also able to share the documentation stored in the document management repository.

The system generates an extensive collection of reports which enable a global analysis of key performance indicators across the entire network and are integrated into the GEA-TOYOTA solution.
