We have picked up numerous industry awards for our quality and also the ethical way we runs our business. We have rigorous standards about the health, safety and welfare of the animals we raise and, not only sells whole birds to retailers

and food chains, but also minimises waste by supplying various parts for specialist food manufacture, such as livers for pâté.

Our company has two main production facilities, one at Debach, a rural farm near Woodbridge in Suffolk that is also home to our headquarters, and the other at Redgrave - also in rural Suffolk.

Another part of our business, Green Label Farms LLP, is directly responsible for all the farms in the Gressingham Group and manages a completely integrated farming system, from breeding through to hatching and rearing the birds we sell.
