

Founded in 1777, our customer is the largest city council in Northern California. It governs an area with an approximate population of over 2 million citizens. The Fire and Police departments of the city are essential arms for the city council. It protects the lives of citizens with its fast response during fire breakouts and crime incidents. The efficiency of these two departments is pivotal to the city council's goal of protecting the well-being of all citizens.

Demand for Migration

To optimize the administrative operations and increase the vigilance of the Fire and Police departments, the city council relied on an enterprise BI application built on Microsoft Azure Commercial Cloud using the Microsoft applications stack (Azure Synapse Analytics, Azure Data Factory, SSIS, Power BI). The application enabled users to consolidate and visualize data from multiple systems to derive valuable insights. It also delivered comprehensive and real-time reporting on patrol officers and firefighters. However, in addition to efficiency, the city council also sought to protect citizen data, applications, and hardware.

Microsoft announced Azure Data
Factory version 1 will depreciate after
31 August 2023. Therefore, we wanted
to swiftly migrate all our data and
applications to a better yet secure
technology environment.

Working closely with the city council's leadership, the IT team planned to transition application workloads from Microsoft Azure Commercial Cloud to a Microsoft Azure Government. The Azure Government cloud environment is built to deliver the highest compliance requirements. Therefore, all the components in the commercial cloud had to be moved to the government cloud (from ADF V1 to ADF V2) without changing any functionalities, business rules, and schedulers.

Consequently, the IT leadership sought a technology partner with experience in Microsoft products and knowledge in migrating applications to the cloud. Given AgreeYa's previous association with the city council and expertise in transitioning government services to other platforms, the leadership approached us for a viable solution.


