The Need for Seamless Data Migration

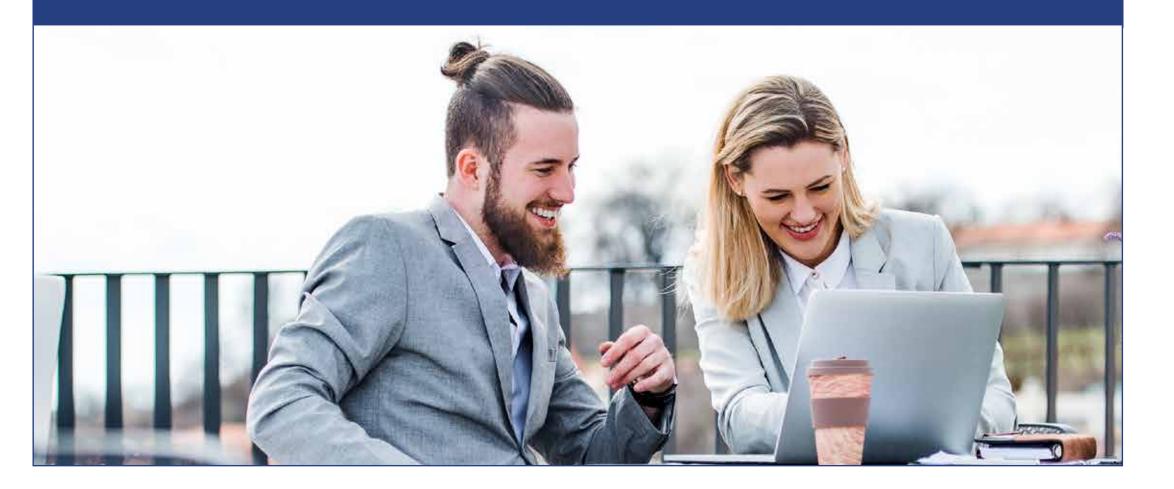

Migrating Historical Data from Acquired Al Platform to the Organization's Microsoft 365

Solution Delivery Methodology

Content Mapping: AgreeYa prioritized the crucial historical data sets over the invalid ones, highlighted the content not utilized for the past three years, exercised data cleansing, and homogenized the data collected from the acquired SharePoint database to make it readily usable in the cloud-based platform's SharePoint database. Such activities provided a clear picture of the content to be migrated.

User Mapping: Our experts created user groups, defined permissions for each and set up an efficient data access mechanism while working closely with the customer's IT department. User mapping activity ensured that employees with due access rights were the only ones to view the data. It ensured proper data governance standards.

Content Migration: ShareGate's migration tool was selected to execute the data migration. Our experts utilized custom-made scripts for performing SharePoint, OneDrive, and Teams migration tasks for ShareGate. The team religiously scrutinized all the heavy data lifting during migration and monitored tasks via ShareGate, examined defects or incorrect outcomes resulting from the heavy migration, and maintained logs to report the integrity of the migrated content.

Sanity Testing: Upon successful data migration from the acquired platform to the customer's platform, our team started rigorous Sanity Testing process to validate the accuracy of migrated data and ensure its availability.
