Very quickly, the challenge of keeping their many spreadsheets organized and up to date became overwhelming, placing a great strain on the team and the stakeholders involved from across the organization.

## The Solution

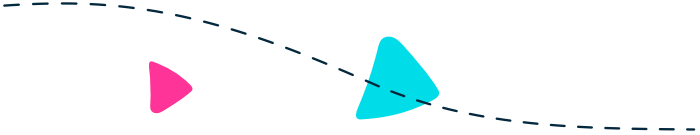
They started to search for a solution that could help them reduce the amount of time spent on manual labor and that could help them take control of their many Compliance processes. “We looked around at the Compliance automation market and found that only The anecdotes Compliance OS had all the features we needed to ensure we could continue to uphold our deep commitment to ensuring optimal security standards and procedures,” says Tamir Ronen. “What’s even more, the UI is fun and engaging – and we actually enjoy using it.”

Their first objective was to eliminate spreadsheets and make sense of their many frameworks – (list of FW [here](#)). “We have SOC 2 on different business units and we have ISO 27001 in multiple regions where we do business. By uploading evidence into The OS, we can now see different and mutual controls in one place. Moreover, when there’s a control for ISO 27001, it automatically reflects it to the correct control for SOC 2, creating a true cross mapping,” says Tamir.

“Another thing is that The OS covers the greatest number of plugins in the market – but of greater consequence, it covers the most important types of plugins from the security ecosystem,” says Adi. And since security is a primary driver for HiBob, they also leverage the data delegation capability, enabling them to retain control of their data at all times.

“We also love the option to share with auditors. We don’t always have the time to sit with auditors and this allows us to give them read-only access and export the evidence to them to save time,” says Tamir. They are also leveraging the policy manager and risk management apps. “This may sound funny, but The anecdotes Compliance OS isn’t only about Compliance. It also helps us understand our GRC and policy management as well.”
