

# OVO Overcomes Complex Global Compliance Management Challenges with anecdotes

## OVO

Founded in 2017, OVO is one of Indonesia's leading players in the digital payment sector. The e-wallet financial application allows people in a financially underserved part of the world to store funds, make transactions, and track payment histories on mobile devices. As of 2019, OVO was valued at \$2.9 billion and had been downloaded more than 100 million times. The company was recently acquired by Southeast Asian ride-hailing and payments firm Grab, who doubled its stake in OVO to 90%, pending approval from regulators.
