The organisation is committed to reducing environmental impact while driving economic success for the Marlborough region - but its size and complexity created challenges around carbon reporting.

Port Marlborough's operations span multiple sectors, from port and marine services to running New Zealand's largest marina operation, and facilitating the region's key industries including forestry, exports and tourism.

Sustainability is embedded in their long-term strategy, guided by the four pillars of People, Planet, Prosperity, and Partnerships. As a values-driven organisation, they align their efforts with the United Nations Sustainable Development Goals (SDGs), focusing on reducing carbon emissions, improving waste management, and enhancing water efficiency.

With a vision to lead as an environmentally restorative port, Port Marlborough sought to ensure their sustainability practices were not only impactful but also transparent and easily auditable. However, the manual processes they used to track and report sustainability metrics presented significant hurdles in their carbon roadmap.

Background

Before implementing BraveGen, Port Marlborough was heavily reliant on manual processes that hindered their ability to efficiently report sustainability metrics.

"Previously, we had no formal system in place; data was managed in an Excel spreadsheet, which made reporting inefficient and subject to human error."

Their existing system involved manual data entry into spreadsheets, which was time-consuming, prone to errors, and made audit trails difficult to manage. Port Marlborough is the only New Zealand port to report to GRI standards, so accuracy and consistency was key.

Supplier reporting was also inconsistent, complicating the ability to track emissions comprehensively across their supply chain and creating headaches for Scope 3.

Port Marlborough needed a solution that could streamline their data collection, simplify reporting, and improve audit processes. After evaluating their options, they chose BraveGen.

Outcomes

- Automated sustainability scorecards that tracked emissions, waste, and water usage, all aligned with their People, Planet, Prosperity and Partnerships pillars.
- Built-in audit trails and data verification, making it easier to trace data back to its source during verification audits.

Since implementing BraveGen, Port Marlborough has seen significant improvements in both efficiency and environmental outcomes:

- Efficiency gains: What once took hours of manual data entry is now handled automatically with oneclick reports, allowing the team to focus on higherlevel strategic initiatives and implementation of these initiatives.

- Environmental impact: In the first half of 2024, Port Marlborough reduced their greenhouse gas emissions by 8% and cut general waste to landfill by 5%.
