# How Did Oblon Address These Market Opportunities?

#### **Patent Filing Strategy**

To help companies prioritize their patent filings and apply their finite budgets, Oblon evaluates the market and technology landscape to determine how an invention fits into a client's portfolio and overall IP and business strategy.

By identifying which ideas have the most commercial value worth protecting, Oblon determines which application should be filed to help defend the client's patent portfolio and which should be dropped. # Improving Efficiency in the Patent Prosecution Process

For Oblon, efficiency relates to several areas of their IP practice. Firstly, the decision to file or not can avoid inefficiencies spent in seeking patent protection on something that just won't pan out commercially. Efficiency also relates to the patent prosecution process itself, the shortening of the cycle

and therefore the cost. Using its office location (right opposite the USPTO) as a strategic advantage, Oblon aims to reduce the number of office actions by hosting personal interviews with patent examiners with the most complete view of prior art using data from Clarivate Analytic's Derwent World Patents Index.

"What [clients] want is 'compact prosecution.'
That means, don't drag things on and on. Get it
done efficiently. We've developed some techniques
including interviewing before the examiner has made
a rejection. If we have very good awareness of what
the best prior art is that the examiner's going to find,
it gives us the opportunity to collaborate with them
to get the cases through efficiently and get applications
allowed many times, without even getting a rejection.
That's hugely valuable to companies."

To support the Compact Prosecution process, Clarivate Analytics conducts an initial search citing pertinent prior art based on the invention disclosure; thus improving the arguments with examiners and making the patent more defensible during PTAB (US Patent Trial and Appeal Board). Overall, this also increases the timeliness of examination which enables the client to make better decisions on whether to continue or abandon the prosecution.

# Conclusion
