Background

Due to an increase in staff numbers, business scope and activities *PMMRAC* had outgrown its management system.

PMMRAC wanted to provide structure and consistency around the information being created by staff and used by departments and functional teams including Essential Services, Community Services, HR, OHSE QA and Finance.

Assessment

Chief Executive Officer, Rachael Green, sought advice from CY Innovations about how to upgrade and improve *PMMRAC's* management system.


CY Innovations conducted internal audits involving all staff and business functions, and reviewed existing systems to produce key functional process maps as the basis for a new business management system.

Deployment
