

Lebanon School District achieves smarter policy management with Diligent Community

Located in New Hampshire, the Lebanon School District serves a diverse student population and is governed by a nine-member school board. The challenge

Fragmented policy management and compliance gaps

Prior to adopting Diligent Community, the district relied on a combination of BoardDocs and Google Drive to manage policies and board materials. This setup created several challenges.

There was no version tracking for policy changes making it difficult to see what had changed. Processes for agenda creation and policy updates were manual, time consuming and open to error.

It was difficult for board members and the public to find and see the latest version of a policy. There were also compliance risks due to missed or delayed updates to policy adoption.

Amy shared how difficult it was to manage policy changes, especially as policies were scattered across folders with no centralized system for tracking edits or approvals. was nearly impossible.

The solution

Streamlined policy governance with Diligent Community

The district implemented Diligent Community in 2024, focusing on the Policy Publisher feature to address its most pressing needs for managing policies. The impact was immediate and transformative.

Policy Publisher allows real-time editing & collaboration with policy committee members now able to make live corrections during meetings, eliminating the need for post-meeting transcription.

Ensuring everyone is working from the current version and change tracking is now easy. Policies are tracked from draft to adoption with a detailed timeline providing full visibility into changes and approvals.

Urgent policies can now be put in place rapidly. For example, the district recently completed a full policy cycle for a major new policy with unexpected speed, as Amy explains, "From a compliance perspective, we had a new policy, a big one on parental rights. And being able to use Diligent Community to go through reads to bring it forward, have people look at it, provide input, and then the policy is there and published. We were able to do that in a 4-day turn around."

Policy Publisher also offers integrated publishing and access to the public. Policies are published directly to the district's transparency website, allowing community members to find and see the most recent policies quickly and easily, resulting in higher engagement and less confusion.
