How Doctolib improves communications with Brevo's API

Doctolib uses Brevo's public API to send a high volume of transactional emails, mainly appointment reminders, teleconsultation notifications, and pending payments.

Process:

Doctolib sends parameters and email content via the API.



Brevo manages email creation, management, and dispatch, guaranteeing fast, secure delivery.

Result:



95% of emails are **delivered** in under 5 seconds.




