Beven Schwaiger CEO, integrum Management Systems Pty Limited The client, one of Australia's largest energy utilities, is responsible for the safe and reliable supply of electricity to 2.1 million people in households and businesses.

With an estimated value of \$3.3 billion, this network spans 24,500 square kilometres and is made up of over 170 major substations, 315,000 power poles and 28,000 smaller substations bound together by 33,000 kilometres of underground and overground cables.

On-going upgrade and investment projects has the client committed to delivering a \$4.2 billion network investment and maintenance program throughout 2014 including building and renewing 59 major substations, constructing 200 kilometres of new transmission lines, upgrading over 450 power lines and maintaining the poles and wires.

With over 5,000 staff and contractors needing a simple to use system to submit Incident reports to the client's Health Safety Security Group on a wide range of incidents, the legacy incident system and call centre was not sustainable.

Further, the mobile nature of the field based workforce required close integration with HR and Asset systems to accurately capture key information on field team, location, supervisor, asset details, motor vehicle details, etc.

The system also needed to integrate with the client's network outage management system which records electricity network incidents as well as with their worker's compensation claims management system.

The project involved significant data migration from legacy systems.

After initial workshops with stakeholders and requirements gathering integrum and the client project team worked towards building a simple to use Initial Incident Reporting (IIR) form and portal.

The IIR allows users to consequence rate the incident across several categories and provides automated notifications to business managers based on severity and category.

This includes automated incident notifications from other systems such as the Outage Management System and involves look ups to data from a number of systems.

Detailed Corrective Action processes are raised from the IIRs to line managers and subject matter experts for assigning actions to closure.

Safety observations, inspections and audit templates provide easy capture integrated with corrective action processes. All with automated email notifications and escalations.

The rich dashboards and business intelligence available to all management levels provide the client's managers with real time report and KPI dashboards and drill downs to underlying records.

The highly configurable software allowed the client to readily build their new integrated QHSE management system for roll out including change management, user training, data migration and system integration in a few months from project commencement.

HAZARDOUS MATERIALS REGISTER & SF6 REPORTING SYSTEM

As a separate parallel project integrum is used by the client to manage and track all hazardous materials within their assets and to manage, record, track and provide annual statutory reporting on SF6 gas management.
