

Health Insurer Addresses Compliance Challenges with Flexible Business Analysis Solution

NTT DATA helps insurer improve processes and systems with a scalable, consistently high-performing team of business analysts.

Abstract

For this healthcare payer, building IT systems capable of keeping up with the industry's many regulatory compliance initiatives as well as consumer and market demands required high-quality business analysis and consistency across delivery. The health insurer partnered with NTT DATA to establish a Business Analysis Center of Excellence (CoE) and a team of business analysts to deliver high-quality business analysis across multiple functional areas and methodologies. NTT DATA's CoE was responsible for hiring, on-boarding, and training analysts, as well as for scaling the team as the client's needs changed. This approach enabled the client to reduce rework by 20% and realize considerable cost savings.

Challenge

The health insurer needed to move its processes and systems to a new platform to better meet consumer, market, and regulatory demands. It determined that high-quality business analysis was a prerequisite for such a large-scale project, a capability it lacked. Among the client's challenges was finding and retaining top-tier business analysts. This had proved to be a difficult, time-consuming, and cost-prohibitive process. The existing full-time business analysis staff did not have the capacity to successfully complete its initiatives. Inconsistent methodologies led to delays and rework, and fluctuating project demands produced unpredictable resource estimates.

Solution

NTT DATA, with its years of business analysis experience and its mature practice, worked with the client to establish a Business Analysis Center of Excellence (CoE). The CoE's goal was to provide business analysis services, such as requirements engineering and enterpirse analysis services. In addition the CoE held the responsibility for on-boarding business analysts and building the requisite baseline knowledge of analysts. Using domain-oriented academy training, NTT DATA deployed business analysts in the client's functional or business areas as needed. These analysts are able to work effectively in the methodologies matching the client's project implementation practices. NTT DATA also introduced a flex-pool resourcing model, enabling a quick response to any short-term spikes in the client's business analyst resource needs. A strong leadership and governance structure was established to provide coaching and support to all business analysts. As part of its service, NTT DATA deployed Requirements Elicitation, Analysis, and Documentation (READ), which was customized and fine-tuned to the client's needs. In addition, requirements quality was measured using NTT DATA's proprietary Requirements Quality Diagnostic (RQD) tool.
