## Seamlessly integrated system landscape increases productivity and compliance

Travel expense reports are subject to complex requirements not only in Italy: receipts must be bundled, labeled with a cover sheet, and archived. This was a labor-intensive manual process at PUMA but is now fully automated.

The foundation for this is provided by the neylux ERP Connector. It links the finance module of PUMA's SAP ERP solution with the new SAP Concur system, the neylux cloud, and the certified archiving solution. When a travel expense report is posted in the finance system, neylux automatically receives a notification. This triggers the retrieval of relevant travel information and receipts from Concur Expense, transfers them into a PDF travel expense form, and sends it to the archiving service provider Faber Systems.
