(ST&R) is an international trade and customs law firm concentrating in assisting clients with the movement of goods, personnel, and ideas across international borders. Being the leading provider of customs and international trade consulting services to the public and private sectors, it is vital that ST&R protect its working systems with the utmost care.

When an organization depends on its data, the challenge is to be able to recover that data with minimal loss and in the shortest possible time should the unimaginable happen. Microsoft® Exchange is an essential tool for ST&R and the firm needed to guarantee fast recovery in case of server failure or database corruption. Also, due to the continuous increase in database size, ST&R needed to regain control and order of its database backup window.

Initially, ST&R came across Vision Solutions though an Exchange 2003 book. However, the firm was later contacted directly by Vision Solutions and chose to see a demonstration of the newest product, Double-Take RecoverNow, a solution that provides Continuous Data Protection (CDP). With all of the hype in the industry today over CDP solutions, it is sometimes hard for organizations such as ST&R to separate the buzz from the benefit. ST&R had read about similar products that deploy continuous data protection in the past but was never impressed by the efforts of other competitors in the field. It wasn't until ST&R was involved in a demonstration of the Double-Take RecoverNow product that the tables turned.

For a company such as ST&R, Double-Take RecoverNow is an affordable data protection software solution and completely applicable for its servers.

Double-Take RecoverNow is a simple and cost-effective way to recover data to any point in time and resume workflow without the pain of recovering from tape. It works with Microsoft Exchange, SQL Server and other Windows-based applications. For ST&R, Double-Take RecoverNow provides an extra layer of e-mail protection, which allows the firm to easily recover individual messages or mailboxes.

Today, ST&R maintains a Windows 2003 Active/Passive Exchange 2003 Email Cluster running on Dell servers with a 1GB network and Double-Take RecoverNow cluster agents running on both nodes. Double-Take RecoverNow is set up to protect these servers for one week, then two weeks of hourly protection and one month of daily protection. This ensures that Double-Take RecoverNow snapshots are created every Friday and then backed up to tape. In this scenario, Double-Take RecoverNow is the primary backup tool while tape is used for archival purposes. ST&R has used the product to recover data approximately 25 times, each time saving around 10 hours of pain and hassle compared to the traditional method of Exchange database recovery, a total of about 250 hours saved. Double-Take RecoverNow also provided a much better response time to the user.
