## X The Challenge

As a fast-growing insurance broker with 150+ locations and 15-20 acquisitions annually, Higginbotham needed a better way to manage vendor payables across its expanding footprint. "From day one, we take over their vendor payables—it has to be seamless," said Tony Haas, Chief Accounting Officer.

Manual, paper-based processes and inconsistent approval workflows created bottlenecks that couldn't keep up with the company's rapid expansion. "With a shared services model and no room for slowdowns, the team needed an automated AP solution to centralize communication, improve control, and eliminate chaos."
